Their interest with the Company is to the extent of shareholding only. 2) 100% shareholding of promoters in Dmat form: All the shareholders in the Promoters / Promoters Group are holding the shares of the Company in Dmat form except Mr. Babulal Ishwarlal Patel. Mr. Babulal Ishwarlal Patel has already given the shares for dematerialization & since the same has been dematerelized, all the promoters holding are now in 100% Dmat form.
