Business Brief

Sensex trades higher after opening at new all-time high

Mumbai, Aug 30 (IANS) Indian equity indices were trading higher after opening at a fresh record high on Friday, following positive cues from Asian peers. At 9:37 a.m., Sensex was up 221 points or 0.27 per cent at 82,556 and Nifty was up 66 points or 0.28 per cent at 25,117.

At the beginning of the trading session, Sensex and Nifty made a new all-time high of 82,637 and 25,249 respectively. The market trend remains positive. On the National Stock Exchange (NSE), 1,276 shares are in the green and 888 shares are in the red.

Almost all indices are trading in the green. PSU Bank, fn service, FMCG Pharma, energy and port bank are major gainers. In the Sensex pack, Bajaj Finance, Bajaj Finserv, HDFC Bank, NTPC, Power Grid, Larsamp7, Titan, M&M, Asian Paints and Reliance are the top gainers. Tata Motors, Tech Mahindra, Wipro, TCS, Sun Pharma and HCL Tech are the top losers. Along with largecaps, there is a bullish trend in midcaps and smallcaps also. The Nifty Midcap 100 index is at 59,139, up 255 points or 0.45 per cent, and the Nifty Smallcap 100 index is at 19,202, up 79 points or 0.41 per cent.

Nifty likely to reach 26,820 in next 12 months: Report

Mumbai, Aug 30 (IANS) Nifty is likely to meet a 12-month target of 26,820, revised higher from earlier target of 26,398, market analysts said on Friday, amid high expectations for a festive season revival, supported by favourable monsoon conditions. Amidst strong infrastructure spending push by the government.

In its report, financial services organisations Prabhudas Lilladher revised Nifty's EPS (earnings per share) projections as the market continues to perform well.

The report valued Nifty at 15-year average PE (19 times) with March 26 FPE of Rs. 1,411 and arrived at 12-month target of 26,820, revised higher from earlier target of 26,398. Currently, Nifty is trading at 18.9 times its one-year forward EPS, which is almost on par with its 15-year average of 17 times in a continuous bull case scenario, the report valued Nifty at PE of 20.2x and arrived at a target of 28,564. In a bear case scenario, Nifty may trade at a 10 per cent discount to a long-period average with a target of 24,407, the report mentioned. Since July 11, Nifty has delivered a return of 1.6 per cent despite rising volatility amid deteriorating geopolitical situation as Indian markets were supported. Markets have experienced extreme volatility due to the Japanese carry trade and geopolitical uncertainty.

Over 200 pc surge in property registrations among Mumbai elderly post-Covid

Mumbai, Aug 30 (IANS) The share of overall property registrations by buyers of age 61 and above surged 204 per cent in Mumbai, increasing from 554 in 2020 to 15,629 in 2023, a study by the report showed. The shift in market dynamics is seen to be driven by elderly buyers sought better properties for a stable lifestyle, a report showed on Friday.

The proportion on registrations in this age group increased from 12 per cent in 2020 to 20 per cent in 2023. In 2023, a total of 22,849 senior citizens registered their property purchases, whereas, in 2024 till July, this number was recorded at 15,278. The report, by Knight Frank India, further, by the end of the year, property registrations by senior citizens is expected to exceed 23,000, maintaining an 18 per cent market share. The shift in market dynamics is seen to be driven by elderly buyers sought better properties for a stable lifestyle, a report showed on Friday.
