Mumbai, August 13 (IANS) Actress-turned-politician Kangana Ranaut celebrated her first Teej festival at the residence of Delhi chief minister Rekha Gupta. The actress expressed her sheer happiness upon being a part of the celebration and called it a homely feeling.

The actress shared glimpses of the festivities on her social media account. Dressed in a vibrant green and orange Paithani saree, Kangana was seen enjoying the celebrations, dancing with other women, applying mehendi and posing with CM Rekha Gupta on a flower-decorated swing.

Sharing a series of pictures from the celebration, Kangana wrote in Hindi, that further translated into English reads as, "Meri pehli Teej ka tyohaar, Rekha didi ke ghar pe, sach mein ek badi bahen ka payaar aur dular bilkul ghar jaisa apnapan. Sabko teej ki anek shubhkamnaein." The actress revealed that it was her first ever Teej celebration at Rekha Gupta's home and that the love and affection of an elder sister made her feel completely at home. Kangana completed her traditional look with a statement choker, matching earrings and bangles, while a red bindi and mehendi added to her festive appearance.

The festive post comes amid Kangana's latest jibe at veteran actor Naseeruddin Shah, post a statement that he made against the current government, while in support of the student protest in Delhi a few days ago.

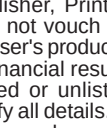
